

LPGA Site To Host Joint Meeting

n LPGA event in Lincoln? — that's right. This past April, Twelve Bridges Golf Club, site for this month's Sierra Nevada/Norcal joint meeting, hosted its first LPGA tour event, remarkably only four months after it opened. The tournament climaxed with a five hole playoff victory by Kelly Robbins, who bested Val Skinner. Prominent PGA tour players, Johnny Miller, and Peter Jacobsen have also graced the fairways at Twelve Bridges. Quite an auspicious beginning for the public course in its inaugural season.

The site was a natural for Golf Course Architect, Dick Phelps of Evergreen, Colorado, and he took full advantage of its special features such as natural granite outcroppings, streams and over 20,000 Oak trees. The site lended itself so well to Phelps design that only 150,000 cubic yards of soil were moved during construction.

Golf Course Superintendent, Neil Hladick, CGCS, arrived at Twelve Bridges from Arizona's Antelope Hills in August of 1994. A graduate Michigan State University in 1976, he is no stranger to golf course construction, having participated in 5 projects while in Arizona. As in any new construction, the challenges are many. In the case of the Twelve Bridges project, none was more prominent than the task of completing construction in time for the LPGA event schedules for the spring of 1996.

With the spring opening and the LPGA event behind him it appeared that Neil and his staff had successfully met their

Reflecting back upon his career, Neil can't remember ever wanting to do anything but work on a golf course. The seeds of superintending were planted early, high school to be exact, and he credits fellow superintendent, Frank Stydnickl as having the most influence professionally.
