Unemployed superintendents, golf professionals, club officials, club managers, golf course owners, educators, students, and any other interested party would be eligible for Associate membership. Associate members shall have all the rights and privileges of the Association except that such members may not vote or hold office.
3. ARTICLE $V$, SECTION 1 (Dues)

Insert the sentence "The dues for Associate members shall be $1 / 3$ of the dues set for Class A, B, and D members."
4. ARTICLE $V$, SECTION 3 (NEW MEMBERS)

Delete the current paragraph and replace it with a new paragraph to read "New members shall at the time of application pay one years dues. On the following October 1st they shall be billed for one years dues prorated to the month of their application.
