**ASSISTANT/ASSOCIATE PROFESSOR OF SUSTAINABLE LANDSCAPE HORTICULTURE - TENURE TRACK POSITION**

The Horticulture and Crop Science Department, Cal Poly State University, San Luis Obispo, CA. Full-time teaching academic year, tenure-track position starting January 3, 2011. This position is responsible for teaching courses in landscape installation and maintenance, construction, contracting, plant materials and other horticulture classes. Required qualifications include: Ph.D. in horticulture, plant science, or closely related field with strong demonstrated undergraduate teaching skills with an emphasis in landscape management including design, maintenance, and construction, experience in sustainable landscape practices, and applied research involvement. Professional experience in landscape horticulture is highly desired. Salary commensurate with experience and qualifications.
