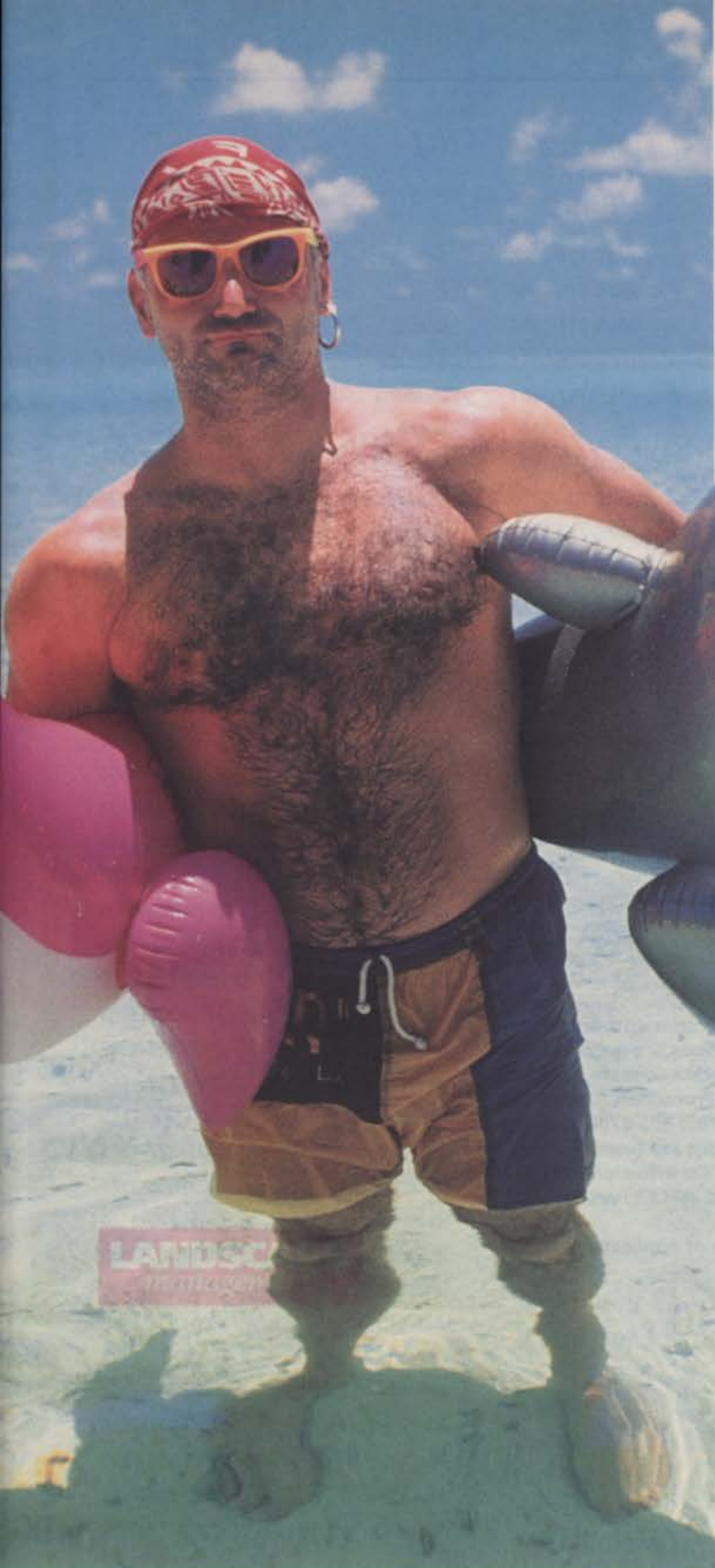

The Associated Landscape Contractors of America (ALCA) offers a Certified Landscape Technician (CLT) program. Twelve states and two Canadian provinces are registered to administer the CLT's exterior program: California, District of Columbia, Illinois, Maryland, New York, North Carolina, Oregon, Texas, Utah, Virginia, Washington, Wisconsin, British Columbia and Ontario.

Program objectives are:

- * To raise the standards of the profession.
- * To encourage self assessment by offering guidelines for achievement.
- * To award recognition to those who have demonstrated a high level of competency in the profession.
- * To improve the performance within the profession by requiring participation in a continuing program of professional development.
