Biographical Note

Horace D. Moore (1821-1915) was a manufacturer of and dealer in tools and lumber and general merchant. After a successful business career in New Hampshire and Massachusetts, Moore began an extensive lumber and manufacturing business in Saugatuck, Michigan in 1857. He was involved in this operation until 1875, having cut more than 200 million feet of timber and employed many tugs and vessels in his business.

Moore devoted his remaining years to farming pursuits, to his land investments in Wisconsin and Illinois, and to his properties of various kinds elsewhere. Included are account books and miscellaneous papers relating to his general store operations, his hotel (the Sherman House), and to his personal and household accounts.

Scope and Contents

The collection consists of account books dealing with the various business enterprises of Horace D. Moore. Also included are account books and miscellaneous papers relating to his general store operations, his hotel (the Sherman House), and to his personal and household accounts.
